Our recent February 9th AMA with the Co-Founder and CEO of UBIX Network & SilentNotary, Max Breus, and Marketing Director, Vadim Germanovich, was not one to be missed! Several major developments, initiatives and milestones were announced. In case you missed it, here is a quick recap with all of the major highlights (with the full AMA transcript below):

Vadim Germanovich: Hello everyone and welcome to the second AMA of 2022. Im excited to be here today with Max Breus, the CEO and Co-Founder of UBIX Network and SilentNotary (UBSN).

Hi Max, how are you?



Max Breus: Except for the fact that I am struggling with COVID issues, everything is good, Vadim. With UBIX and SilentNotary, things are great! We are extremely busy right now with a lot of new developments for SilentNotary and UBIX. I would love to tell our community about everything going on in this AMA, but we need to keep it short as I have a partnership meeting right after this AMA.



Vadim Germanovich: It's very exciting to hear partnership related comments! Can you share some updates with us? What exactly is happening?



Max Breus: Of course. First, following up on the recent Langia partnership announcement, we have made great progress with integrating Langia's systems with our blockchain, however, our work isn't quite done yet. I'm confident that we will be able to re-use a lot of the same integration experiences for potential future partnerships. This way, the integration process can be more streamlined.

This partnership has already opened up great opportunities for us. Furthermore, we see this partnership as an avenue to accessing additional future opportunities for both parties involved!



Vadim Germanovich: Okay great. To another often asked question regarding new listings for the UBSN token. What is happening with potential listings?



Max Breus: I understand the community is very eager to learn about our status with exchanges / liquidity. As you may remember after the last AMA we released our goals for 2022, and obtaining liquidity via new exchanges was one of our top priorities. It's also important to understand that our goal is to legitimize our project via our real use cases and partnerships. We could have already picked out 5–10 exchanges just for the sake of liquidity, however what we are looking for is the right exchange that represents our company's goals and principles.

That being said, <u>I'm happy to announce that we have been pre-approved by one of the top rated regulated</u> <u>exchanges.</u> I want to emphasize the word <u>regulated</u> here.



Vadim Germanovich: Wow, that's amazing!! I'm sure everyone wants to hear which one?



Max Breus: We will be releasing details in the near future. Again, allow me to explain just how important it is for us to choose the right partnerships / exchanges to secure the future of our blockchain, company, and brand.



Vadim Germanovich: I can personally attest to just how many exchanges approach us and offer to list us, and how we turn most down because they don't fit our brand.



Max Breus: Yes, money talks. So nearly every week we receive an offer to get listed somewhere, however we have a different vision - and speaking of which - we were approached very recently...



Vadim Germanovich: By another exchange?



Max Breus: Nope, rather it was a representative from an entire Country! The representative reached out to discuss integrating SilentNotary's system of authentication with some of their capital market <u>requirements.</u> I believe some community members may have heard our last AMA, where I discussed self-sovereign identity. It's quite incredible, and we plan on releasing more news as these plans develop.



Vadim Germanovich: So this is not finalized yet, right?



Max Breus: No of course not, but it's a very good demonstration regarding the future potential of our product. <u>What I can share is that it is a European country.</u> While I am fairly certain that we will slowly and gradually integrate, I unfortunately (at this moment), not authorized to share the country's name yet. I'm sure everyone can understand the bureaucracy involved around government-tech solutions.



Vadim Germanovich: Can you give us some details about how they want to use SilentNotary?



Max Breus: Yes, we learned that many online contract signings can be forged / falsified, as anyone can simply 'click' a button to sign a document today. With SilentNotary, documentation signings can include video snippets, geolocation information, and time stamp / signature verification.

Essentially speaking – just on the credit card payments side – we believe we can make chargebacks a thing of the past. Moreso, we can make buying and selling any property, including real estate – or even selling a car – a painless / simple task utilizing SilentNotary's verification and validation protocol.



Vadim Germanovich: What's going on with the UBSN daily payment program that everyone has been waiting for?



Max Breus: We are ready to go live with our UBSN Airdrop Program, however, we will be doing so via a different approach. Initially, we will only accept 1,000 people into our UBSN Airdrop Program. It will be application based and the only requirement is that you need to have at least 1,000,000 native UBSN tokens in your UBSN/UBX Ubikiri wallet to qualify. After 2 weeks of testing the program with the initially selected 1,000 individuals, we will be able to invite more people to the airdrop program.

We have chosen this method to help unite our community. We call this a 'hybrid DAO,' so instead of us, the admins, deciding who gets into the airdrop program, we will enable our users to invite up to 5 of their friends.

Unfortunately, I have to go to my partnership meeting, but thank you to everyone for joining us for this AMA. Actually, for the next AMA I will be joining you guys from another country as I have to do some traveling to meet some of our new partners. Thank you everyone!



Vadim Germanovich: Well, on that note, I'd just like to say we have an awesome community and a community that has been very supportive - On telegram, twitter, and even now discord is also picking up. As such, we want to put more effort into our community rewards program, which will allow us to reward our content creators in a multi-tier system. I know some of these supporters / community members have been with us for quite some time, and honestly, the images, videos, and memes have been amazing and we want to make sure these creators get paid for all their hard work. We are in the process of finalizing this system and plan on rolling out the full details in the upcoming weeks.

Again, I want to say this as clearly as possible. If you are a content creator, you will be able to earn UBSN with SilentNotary and UBSN.

However, let me also clarify myself when I say it is not just for large influencers. This is meant to be for everyone! We want to empower our community, and reward them.
